It can be used as single layer and/or lamination base film for different applications. It is suitable for thermoforming, flexible packaging and vacuum packaging applications as top and/or bottom foil.

It extends freshness and provides longer shelf life for food products such as fresh and processed meat, processed cheese, etc.
